Representative Matters

Individual—Contract dispute

Secured summary judgment for client dismissing a 12-count cross claim brought against her by a co-defendant and entering judgment in client's favor on her claim for contribution and indemnification in a long-running dispute concerning responsibility for an unpaid debt incurred in connection with storage of many vaults of the co-defendant's personal property.



Wholesale grocer—Workers' compensation retaliation claim

Obtained summary judgment on terminated employee's claim that he was fired in retaliation for pursuing his rights under the Connecticut Workers' Compensation Act in connection with a recent injury on the job, rather than for his violation of company policies on insubordination and civil conduct.

Cigarette and tobacco products distributor—Dismissal of complaint

Obtained complete dismissal of complaint against a Connecticut distributor and its individual owner and president. Several related national distributors claimed that our clients violated Connecticut's cigarette pricing statutes after they lost certain retail customers. After we secured a decision striking all but one count against our individual client, the plaintiffs voluntarily dismissed the remainder of their claims.

In-home IV infusion company—Pregnancy discrimination claim

Defended administrative proceeding brought by terminated IV infusion nurse who claimed she was fired due to her pregnancy, rather than as a result of her violation of company policies and physician orders.

Daycare center—Dismissal of administrative charges

Secured a contested administrative hearing brought against a daycare center by the Connecticut Office of Early Childhood. OEC claimed that the nature-based daycare center violated state regulations by regularly bringing children on to play in a wooded area that had not been licensed as approved outdoor space by the state, despite center having parental authorization for such activities and having done so for more than a decade. Following several days of testimony, the hearing officer dismissed the charges in their entirety.

Individual—Dismissal of defamation claim

Obtained dismissal of defamation complaint filed against consumer client based on online comments about defendant's business. Following our client's filing of a special motion to dismiss and request for an expedited hearing pursuant to Connecticut's anti-SLAPP (strategic litigation against public participation) suit law, the defendant voluntarily withdrew the complaint.
