Electronic lottery payment company—Legislative drafting

Drafted legislation advocating for the passage of lottery reform in the New Jersey Legislature. The bill was signed into law by Governor Murphy and now allows residents of the State of New Jersey to purchase lottery tickets through decoupled debit as an electronic fund payment method.

Former Governors of New Jersey—New Jersey Supreme Court win

Represented every living former governor of New Jersey as amici curiae and argued before the New Jersey Supreme Court on their behalf in support of the pardon power afforded to the Governor through the State Constitution. The New Jersey Supreme Court reversed the judgment of the Appellate Division granting the petition for expungement and remanded the matter to the trial court to enter an appropriate form of order.
