## Representative Matters

### Non-profit—Federal lobbying

The New Jersey Supreme Court reversed the judgment of the Appellate Division granting the petition for expungement and remanded the matter to the trial court to enter an appropriate form of order.

#### Charter schools—Municipal budget dispute

Representing Hoboken's three charter schools in a matter before the Hoboken City Council involving the Council's proposal to exclude the Charter Schools from certain funds appropriated under the 2020 Municipal Budget.

#### Mayoral candidate—Election contest

Secured the dismissal of an election contest brought by a defeated mayoral candidate who lost an election to our client. The dismissal followed a win at the preliminary injunction stage that allowed our client to take office.
